



# INVESTOR OVERVIEW

- A minimum initial capital investment of \$10,000
- Investors will receive an 80% of the net returns generated by investment activities
  - The investors share will be distributed as follows:
    - A quarterly distribution of 35% of the net earnings attributable to the investors will be made after the initial 12 month period
    - 65% of the net earnings attributable to investors will be retained to grow the investable capital base
- Investors may request redemptions semi-annually
- Investors will receive a quarterly statement of the results of operations the fund value will be calculated on a monthly basis and will be utilized to determine per unit values, this per unit value will be the basis for future capital raises as well as for investor redemptions
